# 6-Week Trial Sessions for 2024: Cost \$115 / Student

Please pay by cash or check (written to Sharon Wenger). Payments can either be mailed to the above address, or left in the secure drop box out front.

- Spring Lessons: April 18, 25; May 2, 9, 16, 23 Payment Due April 10.
- Summer Lesson Choices: June 11, 18, 25; July 2, 9; August 6, 13, 20 Payment Due 2 Weeks Prior to the First Lesson.

## STUDIO POLICY

#### **PAYMENT**

- Payment is based on 6 total trial lessons. No further commitment is required after that point.
- Much more than in-person lesson time is covered by payment, including the following:
- a guaranteed time reserved for the student, that is never resold to someone else
- childcare arrangements made for my own children, to keep our time distraction-free
- administrative work & planning time
- studio supplies & prizes
- funding of the studio website
- regular instrument maintenance
- studio upkeep.

Due to the above factors in planning and holding lessons, and the fact that I cannot "resell" an open timeslot when a student cancels, I am unable to refund student cancellations.

• RETURNED CHECKS: A \$25 fee will be charged to cover any bank fees for returned checks.

- **AT LESSONS** Only students are permitted inside.
  - Please park out front, on West Maple Avenue. I will open the door at your child's lesson time. Simply wait in your vehicle until then; do not knock or ring the doorbell as it interrupts the student before you.
  - Sibling-students may be dropped off together, taking turns waiting in my dining room. Simply bring a book, homework or other device to occupy you. (Bring headphones if using a device with audio.)
  - NO FOOD OR DRINK MAY BE BROUGHT INSIDE.
  - Non-student siblings may not be left here to wait during their sibling's lesson; I don't provide childcare.
  - Parents, please be punctual in picking up your child. Since I must give my full attention to the next student, I can't wait with children for parents' arrival.
  - LATE STUDENTS: A text of expected arrival time should be sent if running late. (Phone calls can't be answered.) The lesson cannot be extended for tardiness but must adhere to the established schedule.

### AT HOME

- Practice at home is required and parents are expected to ensure that it is done as asked.
- Books: For children who continue lessons after the trial, further lesson books will be needed as material is mastered. Parents purchase all music books, usually via amazon links (or I can buy & be reimbursed).

### ABSENCES

- Due to the pre-k program I run, as well as being a parent myself, I unfortunately do not have the time required in my schedule to offer make up lessons. If a student cancels, that lesson is simply forfeited.
- If I'm forced to cancel a lesson for the entire studio due to inclement weather or sickness, I will attempt to add-on that missed lesson to the end of the schedule in May. Otherwise, a refund will be given.
- Cancellations should be communicated by text message as soon as possible. Any teacher-cancelled lesson (rare at this time of year) will also be communicated by text ASAP.
- Students who quit prior to the agreed-upon 6-week ending date will not be refunded.

#### DISMISSAL

• Students may be dismissed without refund for failure to comply with studio policy, theft or destruction of property, uncooperative attitude, repeated tardiness or lack of preparedness.

# HEALTH
